### INTRODUCTION

A National Level Conference called PEPSCON 2015 ("Pre-Engineered and Pre Cast Concrete Structures") is being held in Vijayawada, Andhra Pradesh, India on March 6th and 7th 2015 on behalf of Pre Engineered Structures Society of India (PSI), Hyderabad.

PEPSCON 2013 and PEPSCON 2014 was held at Hyderabad, India and was attended by about 300 DEL-EGATES and the response was resounding

### The conference presented the information about:

- 1) Pre Engineered (Structural Steel for Buildings)
- 2) Precast Buildings (Precast Concrete) and
- 3) Other techniques like shortcreting wall with insulation.

It gave a good insight about the precast technology both in concrete and steel to the Builders and Developers in India

The earlier A.P state has been divided into two states, Namely Andhra Pradesh state and Telangana state. For the A.P State, Vijayawada is the new capital city this new capital city is to be formed now.

The state government is earmarking 200 million Sqm of area required for housing the capital city needs.

The state government is proposing to construct the capital city using latest methods of construction technology like pre-cast and pre fabrication structural steel etc., such that the city capital could be built in a span of 5 years substantially.

The infrastructure required for the works is also proposed to be utilizing the pre-cast to a major extent in this major construction activity.

The state government officials have already visited Singapore & Japan and had tie-ups with the government there, for transfer of technology and involve the entrepreneurs in the construction industry from those countries.

There is a big opportunity for the pre-cast machine suppliers and pre-cast manufactures to set up units in Vijayawada for this huge construction activity to start very shortly. Government of India is giving special status to this city and state government by giving concessions on Taxes which can be availed by the industries for a period of not less than 5 years.

We are looking forward for the pre-cast manufactures as well as pre-cast construction companies from abroad to come and attend this conference, forge tie ups with the local entrepreneurs & developers, and participate in the huge construction.


